1. Should the new classification for non-admitted care support the delivery of integrated care between health care settings? If yes, how?

WA Health agrees that the ANACC should support the delivery of integrated care between health care settings, noting the following:

- Ideally the new classification system should be evidence-based where possible recognising the gaps in non-admitted data, yet flexible in its design to support and encourage innovative and/or best practice integrated service delivery models (existing or emerging) across primary, non-admitted and admitted care.
- Integration across health settings is heavily dependent on consistent definitions, the relatability/access of data and appropriate governance and funding mechanisms. Significant effort is required in all of these areas to truly support the delivery of integrated care models.
- If the system is to support integrated care then there needs to be a strong collaborative working arrangement between partner organisations in particular across health sectors including primary care, emergency care and community services.
- Boundary issues in the provision of non-admitted services to patients with mental health conditions where the care type is not 'mental health care' or 'psychogeriatric care'. The integration between settings and clinical areas such as physical health areas and mental health is a priority to reduce health inequalities and to provide a holistic service to the patients. The interface between classifications needs to be considered and not exclude patients with concurrent treatment pathways from different specialties and with co-morbidities. These issues are further discussed under Question 12 re complexity variables.
- The use of electronic health records to allow access to a common source of data across different health settings is a great concept however the reality of this occurring is a much longer term timeframe as the information within these is fragmented and uptake is not compulsory (at present).
- Given that hospital services and primary services are funded through different mechanisms, consideration will need to be given to how funding these two health settings will operate under a shared or integrated care model.

Further State level considerations:

Further work is required from WA Health to better streamline patient administration and clinical management systems to allow 'data sharing/access' across health settings.

Impact of the classification system on shared care models (i.e. hospital based and primary) and the interface with the Medicare Benefits Schedule system.

Further work would need to be undertaken to identify potential hidden activity/costs related to integrated care. For example, "In-reach" by non-admitted clinicians to inpatients is currently not counted i.e. when Rehab in the Home (RITH) clinicians visit inpatient prior to discharge.



2. Should the new classification for non-admitted care services account for and adapt to newer models of care and technology? If yes, how?

WA Health agrees that the ANACC support and where possible adapt to newer models of care and the increasing integration of technology, noting the following:

- Further consideration and consultation should be undertaken on current and emerging models of care for non-admitted services, hospital based, non-hospital based or both.
- Technology is being utilised more in the delivery of non-admitted care, specifically the use of telehealth and technology to support ongoing remote monitoring of patients.
- Regarding telehealth services, both sides of service should continue to be considered in the activity reporting and costing of service delivery.
- Revision of the unit of count may need to be considered to account for where the patient or provider is not present.
- It is recognised significant improvements will need to be made in costing non-admitted care services, in conjunction with improving the capture/reporting of activity data.

Further State level considerations:

Services have experienced that adopting the use of technology can actually increase the costs initially due to infrastructure costs and the cost of educating patients and carers to use the technology.

Innovative funding models may be required to initiate and boost the use of technology in the delivery of services and in funding new models of care, particularly across care sectors.

Current models of funding tend to provide payment to the health service where the patient is based. As there is expansion into different service delivery modes (such as Telehealth where there is more than one Health Service Provider involved) this needs to be considered in the application of funding to the new classification – recognising that the current classification system allocates payments to both provider and patient sites.



3. As the types of care delivered in admitted, non-admitted and primary care are challenged, how can the future ANACC system account for these changes?

As noted in Questions 1 and 2, consideration should be given to models of care that operate across multiple health care settings. This will allow the ANACC to remain flexible for emerging service delivery models while supporting best practice and the use of technology.

However, a significant challenge is the ability to accurately record activity and cost data across these care settings to enable accurate modelling and funding of services. In theory, focusing on recording activity around the patient journey will acknowledge the different settings of care, making it as seamless as possible for the patient and enable modelling of services across health settings. Additionally it is recognised that data should be recorded at a granular level however remain intuitive and not burdensome to clinicians and service providers.

The patient journey spans across primary care, secondary and tertiary care (emergency department, outpatients, inpatient and community settings) and it is important that there are commonalities between concepts and language describing diagnosis, groupings, acuity and comorbidities across classifications.

Further State level considerations:

Significant duplication in the data collected at a local level. How can WA Health improve the applicability of "single entry, multiple uses".

Further consideration should be given to what data is being collected as much of the reported data is not used, or cases where useful data is recorded however not utilised or reported.

How state government can purchase or fund primary health care activities to encourage models that provide a suitable community-based alternative for hospital care.



4. The classification principles have been designed to guide and support the development of the future classification, do you agree with these and/or are there other principles that should be considered in developing ANACC?

Overall, WA Health agrees with the guiding principles for classification development, noting the following:

- Estimates of the activity and cost data may not be stable over time due to changing models of care. It is recognised this will also depend on the flexibility of the classification design and end classes to accommodate changing models of care.
- Consideration of how the ANACC development aligns with other classification systems to ensure comparability of data/services, where possible.
- Recognition also needs to be given to the impact on pricing and funding of non-admitted services which will result from the new classification system.

Further State level considerations: Nil.



5. Should IHPA continue to use service event as the ANACC unit of count? If yes, do you agree with the proposed revised definition of a service event? How could it be improved?

WA Health supports the use of service event as the ANACC base unit of count however recommends that further revision of the definition be undertaken, and consideration be given to bundling/episodic counts, noting the following:

- Service event appears to be the most appropriate count in the absence of a different metric and one that health services are used to reporting. Equally service event is relatively seamless from a patient administration and documentation perspective around accountability.
- Feedback from stakeholders conveyed mixed views towards the revised definition noting that over specification of the interactions is confusing as this conflicts with the main definition component (e.g. whether a provider is present).
- Stakeholders generally supported the inclusion of the clause, "be provided on behalf of the patient during a non-admitted multidisciplinary case conference (MDCC) where the patient is not present".
- The clause, "be provided by the patient in their own environment without the presence of a healthcare provider" was viewed as unclear and open to interpretation regarding what services may be included.
- It is recommended that the scope of services included in the unit of count be reconsidered to account for the increasing use of technology and decreasing reliance on face-to-face service delivery models. However it is also recognised that the definition should not be overly prescriptive about service delivery models so to not limit the development of more effective and efficient mechanisms for delivery of patient care.
- Further consideration given to use of emails and other applications for delivering non-admitted services to understand how these service delivery modes may be quantified.
- Participants agreed that any treatment warranting entry in the medical record should be counted as a service event, regardless of service delivery mode.

Further State level considerations:

How to better capture 'indirect' or 'non-clinical' work related to patient service event, such as advocacy/liaison, preparation, correspondence/documentation.



6. Should an episode be considered as a unit of count in the new ANACC? If not for all conditions, then for which specific conditions?

WA Health supports the consideration of the use of episodic or time-based units of count for specific conditions, however in the interim this should occur through bundling of more granular information (e.g. service events) rather than replacing service event altogether:

- Both episode and service event need to be considered at this early stage of classification development until there is further clarity for which diagnoses and clinical pathways may be considered to be grouped under episode of care or within a bundled package of care.
- Episodic unit of count may be beneficial for settings where there is a lot of interaction with health care providers over a period of time.
- Bundled funding was considered to be a potentially useful model in future to fund care pathways which have consistent and benchmarked procedures and sequences of treatment that are consistent across the jurisdictions.
- Episodic unit of count would better support innovation in service delivery compared to current focus on volume of services/activity through SE. Further, consideration should be given to measuring outcomes or quality of bundled/episodic models of care.
- Episode may better account for complex multidisciplinary care where the amount and volume of total care is important to capture and has significant variability between groups.
- Other factors need to be considered when pricing an episode e.g. number of clinicians involved, time taken, complexity of care, comorbidities.
- The risk relating to using an episode unit of count, when applied in a fixed method, is that funding may not be sufficiently responsive to changing models of care and the setting/method of service delivery. This could inadvertently restrict innovation towards new models of care.
- Concerns regarding a time-based capitation period and the restrictive impact on services' clinical pathways with possible incentive towards gaming were raised.

Specific conditions to be considered for an episodic unit of count need further investigation. Feedback received that certain surgical pathways may be appropriate to be further investigated for the application of episodic unit of count. Palliative care, rehabilitation and stroke were also raised as areas for consideration however stakeholders noted concerns regarding the variability of complexity of patients within these areas/pathways.

Further State level considerations:

WA to further consider which clinical pathways, conditions or models of care would be appropriate for an episodic unit of count and whether these could be modelled at a local level.



7. Non-admitted patients often present with multiple comorbidities, and may be treated under a chronic disease management model. Should the future ANACC system have a separate path for classifying chronic disease patients?

WA Health recommends further consideration is given to separate pathways for chronic disease care, noting stakeholders expressed mixed views whether this should be considered for the classification:

- Further consideration is needed regarding different treatment pathways for complex chronic disease management as the level of complexity with each chronic disease patient may vary significantly.
- Implementing separate pathways may encourage or provide incentive for further development of evidence-based models of chronic conditions care to be adopted.
- Stakeholders noted concerns regarding how to define chronic disease pathways noting complexity of care and potential boundary issues for treating multiple issues. Labelling patients with a chronic disease was considered to potentially not allow the classification to be responsive to changes in patient acuity.
- Participants noted that acuity and exacerbation of conditions fluctuate in the outpatient setting and raised that the classification needs to better define and respond to these changes in acuity. Acuity was considered to be more important than chronicity of a condition. Having a separate chronic disease path may compartmentalise and restrict movement of patients according to acuity and need. The classification would therefore need to consider how to account for patients where the acuity of care may change during a non-admitted episode.
- Consideration should be given to not over complicate the data capture required or classification system itself at least in initial stages.
- Consideration should be given to the UK Patient Pathways program in the design of chronic disease of other clinical pathways for ANACC. An example of the UK Patient Pathways is provided at Attachment A.

Further State level considerations:

8. What implementation timeframe is required for jurisdictions to transition to a patient-based non-admitted care classification system?

The implementation timeframe for ANACC will depend heavily on the resource implications for data collection and reporting, as well as system level changes such as funding models, ICT infrastructure, policies and supporting documentation, education and training requirements. It is recognised significant improvements will need to be made in costing non-admitted care services, in conjunction with improving the capture/reporting of activity data.

IHPA's proposal of an initial version by 2020 seems reasonable depending on the outcomes of this consultation process, and assuming no new data items are required for the classification system. If new data items are required, an initial implementation timeframe of three to five years is more realistic to allow for the implementation of new data items particularly if ICT enhancements/modifications are required and associated costs, validation of these new data items to support pricing of activity, and modelling of funding implications to Health Services.

Further, the ANACC is significantly different to Tier 2 and will require substantial change management and education processes to support its implementation, and associated costs. Specifically, a greater focus on how changes are communicated to clinicians, how they are trained in the use of the system and the consistency of information to be provided across health services.

WA Health seeks further information regarding whether IHPA will consider a costing/validation study to evaluate the introduction of new data items for ANACC, and support pricing and modelling of this classification in the interim until data quality is sufficient.

Further State level considerations:

What new data items are being proposed for inclusion and how can WA Health capture and report these through the existing PAS?

What is the financial impact of the required ICT modifications?

What local training and education elements are required to support the national implementation of a new classification and data elements?



9. What considerations should be made in relation to including a diagnosis-type variable in the future ANACC system?

WA Health notes the following considerations regarding use of a diagnosis-type variable for ANACC:

- Diagnosis term set needs to align with the scope of service delivery i.e. proposed list is tertiary hospital focussed and not applicable to small/medium sites and community based services.
- Consideration given to the capability of ICT infrastructure to support inclusion of diagnosis (etc) term sets, as well as clerical/other support to assist with data entry/validation.
- Consideration given to the service type and what term set should be used; and the mapping of term sets to other classifications (e.g. ICD-10-AM, ACHI SNOMED-CT AU).
- Whether a diagnosis term set is appropriate given the delivery of services by non-medical staff i.e. can all staff diagnose or only a doctor/medical practitioner?
- Diagnosis may not be confirmed in the first consultation, and may take up to two or three consultations to confirm. As such, further consideration should be given to how the ANACC account for where a diagnosis is not able to be determined and whether more general codes should be included for these events.
- The 'principal' diagnosis may also vary from the first consultation to subsequent consultations depending on the condition/s being treated. As such, consideration should be given to the ability to record multiple diagnoses (or such) for a single consultation.
- Diagnosis could be useful for identifying comorbidities.
- The capture of diagnosis in a non-admitted setting may require a significant lead time due to significant implementation requirements e.g. modification of IT systems, training of clinicians, etc.

Further State level considerations:

Noted that some patients are assessed and treated and procedures administered prior to the allocation of diagnosis or, in fact, in order to obtain a diagnosis – how to capture this activity at a local level to ensure accurate costing/modelling of services?



10. Should presenting problem be used as the diagnosis type variable? If yes, do you agree with the proposed definition of 'presenting problem'?

WA Health received mixed views on the use of presenting problem however feedback generally supported the consideration of this variable, noting the following:

- Support for the use of presenting problem noted this approach will be useful for episodes where there is no known diagnosis or the patient is still undergoing investigation.
- WA Country Health Service currently records a list of 'health issue' codes which have been specifically developed for outpatient, primary health, allied health and nursing areas. However these codes are attributed to the clinic in the patient administration system when the clinic is registered rather than being attributed for each individual patient event. The list of health issues is included at Attachment B.
- Noted from use in other areas (e.g. ED and inpatient) that presenting problem may not relate to underlying cause and/or may tend to be non-specific/vague. However the quality of presenting problem data may improve as referred/scheduled service delivery models evolve. As such, another option is to consider the presenting problem/complaint for the referral.

WA Health supports the proposed definition of presenting problem.

Further State level considerations:

Nil.



11. What are your views on the proposed list of initial presenting problem/diagnosis-type and intervention-type groups presented at Appendix A? What refinements should be considered?

WA considers the proposed list of presenting problem, diagnosis and intervention groups is a good first step, however recommends that the groups require further development and refinement:

- Overall, mixed views were received on the proposed list. Some stakeholders noted the list was granular enough and comprehensive. While others noted that the list was more focussed on a tertiary hospital setting and further development was required for small to medium hospitals, community services, home-delivered services as well as interventions undertaken by nursing and allied health clinicians.
- Feedback regarding the number of presenting problem/diagnosis-type groups indicates that the degree of granularity for the diagnosis groupings is sufficient; however the procedures/intervention groups may need further development to better represent the nursing, allied health and the primary setting.
- Feedback noted that the development of a list containing multiple concepts must remain clinically meaningful, intuitive and simple to use for clinicians. Concerns were noted regarding the data quality of a list that may be too prescriptive or unintuitive.
- Implementation of such a list must be strongly evidence-based to demonstrate a strategic/clinical benefit given the significant resource and time implications for implementation.
- WA Health recommends that IHPA provide further information on whether a nomenclature based term set such as SNOMED-CT AU was considered for use in the ANACC. A term set may have some validity over a diagnosis type classification especially for services where a diagnosis may not be reached.
- It was recommended that for many cases or clinical pathways, multiple diagnosis codes would be required. This may be in the form of principal and additional. An example of this is a patient with multiple fractures/trauma. Consideration should be given to how these patients would be classified and how the diagnosis or multiple diagnoses for these patients would be captured. This issue was also raised in relation to 'multi-speciality' clinics (e.g. cardio/metabolic where a team manage genetic/metabolic cardiac conditions) where more than one condition may be treated for the patient. These patients generally display higher levels of comorbidities/complexity. Regarding cardio/metabolic, under the proposed list, does not fit well under MDC 5 or MDC 10.
- Is diagnosis to be attributed to the referral or the actual service event?
- Further consultation may be required with the primary sector to investigate how the list of diagnosis, presenting problem and interventions may apply in the primary setting to better enable comparability of data or integration of services in future years.



- Consideration given to development of business rules for when specialities cross multiple MDC codes, as it will be complex for the clinicians to search through all diagnosis groups to find the most appropriate code. For example, a vascular clinic may utilise codes under MDC 5, MDC 22, and MDC 9.
- Further review of diagnoses related to acquired brain injury, neurosurgery and head trauma. Noting there are codes included under MDC 01 and MDC 21, concern was raised there may not be much clinical value in grouping these patient groups to group all ABI's together.
- Under the proposed list, it would appear that the endocrine surgical team will be selecting the same MDC codes as the endocrine medical team. This may be fine however it is not that helpful for clinical separation of conditions and management. Some endocrine teams do run collaborative clinics but the clinical pathways for surgical patients are quite different to those able to be medically managed. Consideration will need to be given to ensuring different clinical pathways for patients that can be identified in the classification structure.
- Further consideration given to how to capture adult gender diversity services.
- Further consideration of diagnosis codes/groups for facial trauma and fractures which at present appear to be grouped under fractures to the head. This aggregation is not clinically helpful as these patient cohorts need to be separated.
- Further clarity is requested on where pre-admission will sit under the proposed list? If pre-admission clinics are required to use multiple categories for the primary diagnosis and reason for surgery this may be overly complex for the clinicians.
- Further clarity is requested on how nuclear medicine therapy will be classified under the proposed list.
- Further consideration given to classification of hand fractures and tendon repairs. Current list only includes injuries to upper limb under MDC 21.
- It was noted that procedures and diagnoses are different concepts and that the procedure/investigation/treatment plan may be used to determine what the diagnosis of the patient is. Therefore, further clarity should be provided on how these variables may be used in the classification system.
- Stakeholders noted the title of Appendix A was misleading as the table related specifically to diagnosis, presenting problem and interventions; and may have created the perception that this was the only grouping variables to be considered. In future, it is recommended that more specific titles should be applied so that stakeholders do not perceive this list as a comprehensive representation of the variables to be considered for ANACC.



WA Health has included other information which has been provided by Health Services for the IHPA's reference at Attachments C, D and E.

- Attachment C provides an indication of commonly used diagnosis descriptors categorised by Major Diagnostic Category.
- Attachment D defines a list of relevant diagnosis codes and corresponding ICP2 terms by Allied Health discipline currently used in the WA Country Health Service.
- Attachment E provides an overview of the 'service types' currently recorded by the WA Country Health Service and the volume of counts for each service.

Further State level considerations:

Reporting of diagnosis variables must be implemented in the PAS in a consistent state-wide approach to ensure comparability and quality in data.

Consideration must be given to how the implementation of these variables will integrate with public private partnership providers.

Variation across clinic PASs and their interface with WA's central webPAS may impact on the ability and time required to capture new data elements across the whole patient journey.

Mapping will be required between PASs in order to capture the necessary data elements for particular clinical areas that have their own PASs; including radiation oncology, cardiology, pulmonary.

Treatment provided to a patient in both public and private settings for the same diagnosis, such as radiation oncology, needs further consideration about how these will be counted and costed.

Implementation of a diagnosis type list into PAS will need to ensure that clinics that operate under multiple diagnosis groups will have access to the appropriate codes.



12. Do you agree with the list of complexity variables presented in Section 5.3? What other variables should be considered for the new ANACC system?

WA Health generally supports the proposed list of complexity variables including age, comorbidities, multidisciplinary, new/repeat visit; noting the following:

Age

 Noted that certain age groupings may be more relevant to specific clinical pathways/conditions however in general support noted for young (0 – 4 years) and older (65+ years) patients.

Comorbidities

Consideration given to patients in palliative care, a mental health condition or with disability as this may result in greater resources required.

Multidisciplinary

 Multidisciplinary involvement is indicative of input depending on how teams, clinics and resources are structured. Encouraging models that promote patient-centric integrated care is supported however needs further exploration. For example, multidisciplinary care can include clinicians within the same clinic, from different clinics within the same hospital, or from different hospitals. These variations in service delivery should be considered regarding how they may be accounted for in the data/classification without dis-incentivising patient-centric care.

New/repeat visit

• It was noted that new visits do not always result in higher resources as in some cases more investigative work is undertaken in subsequent return visits (especially when trying to confirm a diagnosis).

Providers

• Further clarity is requested on what is defined as a 'health care provider' i.e. discipline or qualification. Assume this refers to the principal profession/discipline. If so, need to be careful not to disadvantage models of care where the principal profession may be led by nursing or medical clinicians.

Other variables to be considered

- Homelessness: is a factor which significantly increases the amount of time required for discharge planning, including liaising with external agencies outside health and carers. Homelessness may also impact on length of stay for inpatient and may increase the risks for return visit in outpatients.
- Indigenous status: Aboriginal or Torres Strait Islander patients may need different care needs due to cultural reasons, which may result in increased resource requirements. It was noted that standard clinical pathways may not be appropriate for this patient cohort and require specialised pathways.



- Culturally and Linguistically Diverse (CALD) patients: where an interpreter is required.
- Social complexity/reduced social supports: similar to homelessness, increasingly dispersed, non-nuclear families require increased resources for discharge planning and assertive follow-up to actively prevent a return visit to an outpatient setting. This factor is specifically important for child and adolescent services however this may be a consideration in other age groups and specialties.
- Other 'social' factors: refers to the multiple social reasons and complaints that may be the main reason for a patient to present and re-present to multiple providers and clinics. The patient is not seen without a reason however that reason may not always be related to diagnosis.
- Mental Health: refers to non-admitted patients with mental health conditions where the care type is not 'mental health care' or 'psychogeriatric care' due to the primary goal of care not relating to these care types. As such, these patients are included under the non-admitted scope however can be more complex and therefore require additional resources to treat.
- Child at risk: stakeholders noted that the involvement of the Department of Communities and Child Protection significantly increases the resources requirements for a patient. This is particularly relevant for antenatal clinics, as noted by a social worker:

This requires pre-birth planning and generally consists of a minimum of three meetings with child protection and stake holders from health that are generally 2 hours in length resulting in adequate documentation in medical records, liaison with patient, meeting patient at their health appointments then significant work in safety planning for the birth. I would estimate at least 12 hours direct patient contact and several hours of follow up documentation phone calls information sharing etc.

 Patient acuity: The classification does not refer to degree of patient acuity and the potential impact on both cost and patient complexity. WA notes patient acuity has been considered within the AECC and the AMHCC classifications. In order for the classification to be responsive to patients' changing clinical urgency and acuity of symptoms whilst remaining in an outpatient setting, an acuity variable and/or rating scale may ensure the classification is responsive to changing models of care. This is particularly relevant where acute patients are increasingly being able to be treated outside hospital. Demonstrating changing patient acuity may also better interface with the AECC classification particularly in situations where patients are being discharged directly from emergency departments directly to non-admitted services.

Further State level considerations:

MDC at small sites can be ad hoc and clinicians will record their individual participation rather than noting against an individual multidisciplinary clinic. Further investigation needed re how to improve reporting practices.



Attachment A: UK Patient Pathway example

Below is a description of how Patient Pathways are managed in the UK to facilitate the 18 week and cancer wait targets.

- A patient is referred to a specialty (e.g. ENT). The referral is registered onto the PAS under ENT and a unique pathway identifier is generated.
- All future activity for the episode of care is booked under this pathway identifier. The ENT service has responsibility for managing it.
- Any inpatient events, outpatient attendances or patient contacts are recorded linearly.
- The pathway can measure patient timelines and number of events.
- Where a patient is referred on to another specialty for the same condition, the same pathway is used, giving the ability to measure across services.
- If the patient is referred on for another condition, a new pathway identifier is generated.
- Patients can have multiple pathways running concurrently.
- Pathway IDs can be shared by providers, giving a picture of the entirety of the patient journey.
- This model has a significant requirement for admin staff to book under the correct pathway.
- Reports can be developed to allow management of patient pathways i.e. all patients who are close to 18 week and who do not have a recorded treatment.

01 SCREENING

Relates to the application of a recognised rapidly applied test/examination for the presumptive identification of unrecognised disease or defect.

02 ASSESSMENT

Relates to systematic, documented physical/social/emotional/ environmental assessment.

Excludes Psychometric Assessment (Refer to Code 03).



03 PSYCHOMETRIC ASSESSMENT

Relates to a systematic/documented/recognised psychological assessment.

41 CONTACT TRACING

Relates to any contact tracing episode.

43 COMMUNITY MOTHERS PROGRAM

Relates to the specific Parent Education Program. Service Providers must have undergone the training at Curtin University.

44 WILSTAAR Program

Relates to the specific program re infant language screening, test acceleration and /or remediation.

45 ADL (Activities of Daily Living)

Relates to ADL in the Aged Care Area.

46 TRIPLE P (Positive Parenting Program)

Relates to the specific presentation of PPP groups and follow up.

47 BEST BEGINNINGS PROGRAM

Relates to the specific Best Beginnings Program.

48 PROTECTIVE BEHAVIOURS PROGRAM

Relates to the specific presentation of the Protective Behaviours Program.

49 ASTHMA FRIENDLY SCHOOLS PROGRAM

Relates to the specific Asthma Friendly Schools Program.

50 EXTERNAL FIXATION DEVICE

Includes the application, removal & adjustment of such items as Plasters, Splints and backslabs.

51 LIVING WITH DIABETES PROGRAM

Relates to the specific Living with Diabetes Program.

52 EARLY DISCHARGE PROGRAM POSTNATAL HOME VISIT, Birth-14

DAYS

Relates to contact by Early Discharge Program Nurse during the first 14 days.

NB This code should be used by Community Health Nurses carrying out the Early Discharge Program, it *should not* be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may be used more than once for each individual client.

53 EARLY DISCHARGE PROGRAM POSTNATAL HOME VISIT, 15+ DAYS

Relates to contact by Early Discharge Program Nurse after the first 14 days.

NB This code should be used by Community Health Nurses carrying out the Early Discharge Program, it *should not* be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may be used more than once for each individual client.



54 MINOR SURGERY

Includes minor 'lumps and bumps', toenails, curettage of warts etc.

55 PROPHYLACTIC TREATMENT

Relates to intervention/treatment for contacts of people who have a notifiable disease, ie they do not have the disease, but may be living with someone who does.

56 BIRTH TO SCHOOL ENTRY PROGRAM, UNIVERSAL POSTNATAL FIRST

HOME VISIT, BIRTH -10 DAYS

Relates to a Universal Postnatal visit at birth -10 days to initiate and build relationships with the family.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. Codes 56,57 & 58 are mutually exclusive, ie only one of these three codes may be used once in any individual baby.

57 BIRTH TO SCHOOL ENTRY PROGRAM, UNIVERSAL POSTNATAL FIRST

HOME VISIT, 11-21 DAYS

Relates to a Universal Postnatal visit at 11-21days to initiate and build relationships with the family.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. Codes 56,57 & 58 are mutually exclusive, ie only one of these three codes may be used once in any individual baby.

58 BIRTH TO SCHOOL ENTRY PROGRAM, UNIVERSAL POSTNATAL FIRST

HOME VISIT, 22+ DAYS

Relates to a Universal Postnatal visit at 22+days to initiate and build relationships with the family.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. Codes 56,57 & 58 are mutually exclusive, ie only one of these three codes may be used once in any individual baby.

59 BIRTH TO SCHOOL ENTRY PROGRAM, 6-8 WEEK CONTACT

Relates to contact at 6-8 weeks of age focussing on Child Development and psychosocial health. Health Issue is 1401 (if normal) or 14XX as appropriate if development is not normal.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may only be used once for each individual baby.



60 BIRTH TO SCHOOL ENTRY PROGRAM, 3-4 MONTHS CONTACT

Relates to contact at 3-4 months, focussing on Child Development and psychosocial health. Health Issue is 1401 (if normal) or 14XX as appropriate if development is not normal.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may only be used once for each individual baby.

61 BIRTH TO SCHOOL ENTRY PROGRAM, 8 MONTH CONTACT

Relates to contact at 8 months of age focussing on Child Development and psychosocial health. Health Issue is 1401 (if normal) or 14XX as appropriate if development is not normal.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may only be used once for each individual baby.

62 BIRTH TO SCHOOL ENTRY PROGRAM, 18 MONTH CONTACT

Relates to contact at 18 months of age focussing on Child Development and psychosocial health. Health Issue is 1401 (if normal) or 14XX as appropriate if development is not normal.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may only be used once for each individual baby.

63 BIRTH TO SCHOOL ENTRY PROGRAM, 3-3.5 YEAR CONTACT

Relates to contact at 3-3.5 years, focussing on Child Development and psychosocial health. Health Issue is 1401 (if normal) or 14XX as appropriate if development is not normal.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may only be used once for each individual baby.

64 BIRTH TO SCHOOL ENTRY PROGRAM, SUBSEQUENT HOME VISIT, Birth - 12 MONTHS

Relates to a subsequent Home Visit conducted during the first 12 months of the baby's life to follow up on issues identified during the Universal Postnatal first Home Visit.

NB This code should be used by Community Health Nurses carrying out the Birth to School Entry Universal Prevention and Early Detection Schedule. This code may be used *more than* once for each individual baby.

65 ELECTROCARDIOGRAPH

Relates to the Service Provider performing an ECG on a client.

66 RADIOLOGY

Relates to the Service Provider taking xrays.



67 PHLEBOTOMY

Relates to the needle puncture of a vien for the drawing of blood.

68 PPEI (Promotion, Prevention and Early Intervention Program)

Relates to the specific program of PPEI. It is the application of the Family Partnership approach, using guided promotional interviews, to promotion of infant well being and development, primary prevention of infant/parent psychosocial problems and early intervention where required.

69 PEDS (Parents' Evaluation of Developmental Status)

Relates to the application of a validated parent completed child development Screening tool for the presumptive identification of unrecognised Developmental disease or defect in children 0-8 years. Health Issue 1401 if Normal or 14XX as appropriate if development is not normal.

NB: This code should be used by clinicians carrying out opportunistic contacts only with children, and can be used on multiple occasions. PEDS is administered as a scheduled part of the Birth to School Entry contact at 3-4 months, 8 months, 18 months and 3 years, and the appropriate BTSE service provision code is used at this time. PEDS is also administered as a scheduled part of the School Entry Screening – Vision and Hearing, and the appropriate school entry Health Issue code is used. (ie, this code is used as the secondary SP code, not the Primary SP code).

70 ASQ (Ages and Stages Questionnaire)

Relates to the application of a validated parent completed child developmental screening tool for the presumptive identification of unrecognised developmental disease or defect in children 0-5.5 years. Health Issue 1402 if used secondary to PEDS.

71 ASQ:SE (Ages and Stages Questionnaire: Social Emotional)

Relates to the application of a validated parent completed child developmental screening tool for the presumptive identification of unrecognised behavioural / emotional disease or defect in children 0-6 years. Health Issue 1402 if used secondary to PEDS.

72 ASQ & ASQ:SE

Relates to the application of validated parent completed child developmental screening tools for the presumptive identification of unrecognised behavioural/emotional or developmental disease or defect in children 0-6years. Health Issue 1402 if used secondary to PEDS.

73 POST-OP REVIEW

Relates to the Service Provider providing a Post-Op review for a client.

74 OFFER: BTSE POSTNATAL FIRST CONTACT BELOW THE AGE OF 10 DAYS

Relates to contacting the primary care provider to offer a home visit or clinic visit for a universal postnatal first contact under the Birth to School Entry Policy schedule before the infant is 10 days old. This code can only be used once per client. Use this code only when contact is made directly with the primary care provider.



75 OFFER: BTSE POSTNATAL FIRST CONTACT AFTER THE AGE OF 11 DAYS

Relates to contacting the primary care provider to offer a home visit or clinic visit for a universal postnatal first contact under the Birth to School Entry Policy schedule after the infant is 11 days old. This code can only be used once per client. Use this code only when contact is made directly with the primary care provider.

76 EDINBURGH PND ASSESSMENT AT 6-8 WEEKS. BTSE CONTACT

Relates to the use of the Edinburgh Postnatal Depression Scale at 6-8 weeks postnatal under the Birth to School Entry Policy schedule. This code can only be used once per client.

77 EDINBURGH PND ASSESSMENT AT 3-4 MONTHS. BTSE CONTACT

Relates to the use of the Edinburgh Postnatal Depression Scale at 3-4 months postnatal under the Birth to School Entry Policy schedule. This code can only be used once per client.

78 EDINBURGH PND ASSESSMENT AT 8 MONTHS. BTSE CONTACT

Relates to the use of the Edinburgh Postnatal Depression Scale at 8 months postnatal under the Birth to School Entry Policy schedule. This code can only be used once per client.

200 ENHANCED HOME VISITING SERVICES

Relates to the provision of the Enhanced Home Visiting Services under the Birth to School Entry Policy schedule.

201 LACTATION CONSULTANCY

Relates to the services provided by a Lactation Consultant.

202 SLEEPMATTERS PROGRAM

Sleepmatters is a targeted intervention program for Child Health Nurses to offer to parents of children 8-18 months with behavioural sleep issues.

203 POSTNATAL PARENTING GROUPS

Relates to the provision of a Postnatal Parenting Group for primary care providers of infants less than 12 months of age.

204 TASTE BUBS PROGRAM

Relates to the specific provision of the Community Health Taste Bubs program.

205 ABORIGINAL CHILD HEALTH CHECKS WITHIN 4 WEEKS OF BIRTH

Relates to the contact within 4 weeks of birth under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.

206 ABORIGINAL CHILD HEALTH CHECKS AT 6 MONTHS Relates to the contact at 6 months under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.



207 ABORIGINAL CHILD HEALTH CHECKS AT 12 MONTHS

Relates to the contact at 12 months under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.

208 ANNUAL MEDICAL AB CHILD HEALTH ASSESSMENT: 12 MONTHS

Relates to the 12 month old assessment provided by a Community Health Medical Officer. This code can only be used once per client.

209 ABORIGINAL CHILD HEALTH CHECKS AT 2 YEARS

Relates to the contact at 2 years under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.

210 ANNUAL MEDICAL AB CHILD HEALTH ASSESSMENT: 2 YEARS

Relates to the 2 year old assessment provided by a Community Health Medical Officer. This code can only be used once per client.

211 ABORIGINAL CHILD HEALTH CHECKS AT 2.5 YEARS

Relates to the contact at 2.5 years under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.

212 ANNUAL MEDICAL AB CHILD HEALTH ASSESSMENT: 3 YEARS

Relates to the 3 year old assessment provided by a Community Health Medical Officer. This code can only be used once per client.

213 ABORIGINAL CHILD HEALTH CHECKS AT 3.5 YEARS

Relates to the contact at 3.5 years under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.

214 ABORIGINAL CHILD HEALTH CHECKS AT 4 YEARS

Relates to the contact at 4 years under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.

215 ANNUAL MEDICAL AB CHILD HEALTH ASSESSMENT: 4 YEARS

Relates to the 4 year old assessment provided by a Community Health Medical Officer. This code can only be used once per client.

216 ABORIGINAL CHILD HEALTH CHECKS AT 4.5 YEARS

Relates to the contact at 4.5 years under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.

217 ABORIGINAL CHILD HEALTH CHECKS AT 5 YEARS

Relates to the contact at 5 years under the Enhanced Aboriginal Child Health Schedule undertaken by the specified health professional. This code can only be used once per client.



218 ANNUAL MEDICAL AB CHILD HEALTH ASSESSMENT: 5 YEARS

Relates to the 4 year old assessment provided by a Community Health Medical Officer. This code can only be used once per client.

219 HAEMACURE TEST

Relates to the assessment of haemoglobin levels in the Aboriginal population.

220 SCHOOL ENTRY SCREENING - KINDERGARTEN

Relates to the School Entry Health Assessment carried out by the School Health Service for children in Kindergarten. This code can only used once for each child even if the screening is carried out over 2 days.

221 SCHOOL ENTRY SCREENING – PRE-PRIMARY

Relates to the School Entry Health Assessment carried out by the School Health Service for children in Pre-Primary provided that the child has not been screened in Kindergarten. This code can only used once for each child even if the screening is carried out over 2 days.

222 SCHOOL ENTRY SCREENING - YEAR 1

Relates to the School Entry Health Assessment carried out by the School Health Service for children in Year 1 provided that the child has not been screened in Kindergarten or Pre-Primary. This code can only used once for each child even if the screening is carried out over 2 days.

223 TARGETED WEIGHT ASSESSMENT

Relates to the provision of a Targeted Weight Assessment as per the Child and Community Health policy if a concern is raised about a child's weight in the school setting.

224 HEADSS ASSESSMENT

Relates to the use of the HEADSS screening tool as part of conducting a psychological risk assessment of an adolescent.

225 BRIEF INTERVENTION

Relates to the use of a Brief Intervention Tool to conduct an assessment and appropriate intervention to achieve a specific purpose and client goal. It may include weight loss, smoking cessation and drug addiction.

226 HEALTH PROMOTION – EDUCATION TO STUDENTS

Relates to the provision of Health Education/Promotion activities to students in a school setting.

227 HEALTH PROMOTION – EDUCATION TO PARENTS/CAREGIVERS

Relates to the provision of Health Education/Promotion activities to parents/caregivers of students in a school setting.

228 HEALTH PROMOTION – EDUCATION TO SCHOOL STAFF

Relates to the provision of Health Education/Promotion activities to School Staff in a school setting.



229 PASH – PROMOTING ADOLESCENT SEXUAL HEALTH PROGRAM

Relates to the specific provision of the PASH program in schools.

230 SEXUAL HEALTH TOOLKIT

Relates to the use of the Sexual Health Toolkit in schools.

231 PEG FEED IN SCHOOLS

Relates to the provision of nutrients via a Percutaneous Endoscopic Gastrostomy (PEG) and education/management in the Education Support School setting.

232 TRACHEOSTOMY CARE IN SCHOOLS

Relates to the care of a client with a tracheostomy in an Education Support School setting.

233 OXYGEN THERAPY IN SCHOOLS

Relates to the provision of Oxygen Therapy to a client in an Education Support School setting.

234 HEALTH CARE PLANNING WITH SCHOOL STAFF

Relates to liaising with school staff about the completion/education/management of a Health Care Plan for a student.

235 HEALTH CARE PLANNING WITH STUDENTS OR PARENTS/CAREGIVERS

Relates to liaising with students or parents/caregivers about the completion/education/management of a Health Care Plan for a student.

236 WORKING IN PARTNERSHIP WITH SCHOOL STAFF OR PRIMARY CARER

TO SUPPORT THE COLLECTION OF IMMUNISATION SURVEILLANCE DATA

Relates to all immunisation surveillance matters undertaken to maximise immunisation coverage in the school setting. Excludes the provision of vaccinations.

237 PRIMARY CARE TRIPLE P

Primary Care intervention: Practical advice offered at a planned consultation (20-30 minutes face-to-face or via telephone) providing narrow, focused parenting skills training targeting discrete child behaviour problems – aided by *Triple P Tipsheets* (Level 3).

238 SEMINAR SERIES TRIPLE P

Relates to the delivery of Seminar Series Triple P. Brief intervention series of 3 stand alone 90 minute parenting advice seminars for large groups of parents with children aged 3-8. Targets common behaviour difficulties or development transitions (Level 2).

239 GROUP TRIPLE P

Relates to the delivery of Group Triple P. Broad focused parenting support program: 4 weekly group sessions and 4 follow up telephone calls (as part of 8 week program), for parents of children aged 3-8 focussing on 2 or more mild/moderate behaviour problems (Level 4).



240 LIFESTYLE TRIPLE P

Relates to the delivery of Lifestyle Triple P. Multi component intervention for parents of children aged 5-10 who are overweight or obese. 10 group sessions followed by 4 telephone calls.

241 CHILDREN IN CARE ASSESSMENT

Relates to the provision of a Health Assessment to a child in care after a referral from DCP. Use with Health Issue 1401.

242 ANTENATAL CHECK: INITIAL VISIT

Relates to the antenatal assessment/education carried out on initial visit.

This includes recording medical history and antenatal assessment including Blood Pressure, Weight, Height, Urinalysis, EPNDS and expected date of delivery.

243 ANTENATAL CHECK: 13-20 WEEKS GESTATION

Relates to the antenatal assessment/education carried out at 13-20 weeks including testing BP, Weight, Urinalysis, Oedema, Vaginal Discharge and random Blood Sugar levels.

244 ANTENATAL CHECK: 21-28 WEEKS GESTATION

Relates to the antenatal assessment/education carried out at 21-28 weeks including testing BP, Weight, Urinalysis, Oedema, Vaginal Discharge, Fundal Height, Fetal Movements, Heart Rate and Breast Examination.

245 ANTENATAL CHECK: 29-35 WEEKS GESTATION

Relates to the antenatal assessment/education carried out at 29-35 weeks including testing BP, Weight, Urinalysis, Oedema, Vaginal Discharge, Fundal Height, Fetal Movements & Position and Heart Rate.

246 ANTENATAL CHECK: 36 WEEKS+ GESTATION

Relates to the antenatal assessment/education carried out at 36 weeks or more including testing BP, Weight, Urinalysis, Oedema, Vaginal Discharge, Fundal Height, Fetal Movements & Position and Heart Rate.
